2024-2025 REPORT TO THE COMMUNITY



DEAR FRIENDS

As the stewards of our downtown district, Playhouse Square is working beyond the stage on initiatives designed to create a must-visit destination for Northeast Ohio residents and visitors from out of town, complementing the efforts of downtown and regional partners to elevate Cleveland's profile for business, living and tourism. This fiscal year, we opened The Bulkley Residences, welcomed five new restaurants and bars to our District, and completed renovations to our hotel, the Crowne Plaza Cleveland.



Our 2024-2025 KeyBank Broadway Series got off to a sweet start as we facilitated the first-ever Neil Diamond artifact donation to the Rock & Roll Hall of Fame and Museum, complementing the run of *A Beautiful Noise*. Then things heated up as we saw *Some Like It Hot*, *Life of Pi*, *Parade*, & *Juliet, Shucked* and *Kimberly Akimbo* command the stage in turn for our 41,000 season ticket holders and other audience members. And of course, we did not miss our shot to celebrate “HamilTEN” with a return engagement of *Hamilton* during its triumphant 10th anniversary.

Four national Broadway tour launches are on the books for upcoming seasons — *The Notebook*, *Hell's Kitchen*, *Spamalot*, and *Death Becomes Her* — made possible by Ohio's dedicated tax credit for theatrical productions, reinforcing Playhouse Square's industry reputation and strengthening Cleveland's economy.

In the ninth year of our partnership with the University of Akron, more than 2300 season ticket holders were entertained by *TINA: The Tina Turner Musical*, *Dear Evan Hansen*, *Hadestown*, and *Come From Away* at E.J. Thomas Hall and a special “Broadway at the Ballpark” event with the Akron Rubberducks.

We opened our 2024-2025 Children's Theater Series with *Velveteen*, *A New Musical*, the first show created and self-produced by Playhouse

Square for young audiences. Three more productions are being developed with two set to premiere during our 2025-2026 season.

In the spring, we celebrated the 10th anniversaries of both Disney Musicals in Schools presented by Dee and Jimmy Haslam and the Dazzle Awards presented by Pat and John Chapman and supported by PNC. It has been gratifying to see the tremendous positive impact these programs have had on our community and students. Three Dazzle Awards alumni made their Broadway debuts this season and 2025 Dazzle Awards Best Actress Mira Cahalane won a scholarship at The Jimmy Awards, the national high school musical theater awards ceremony.

Our ongoing work to create a welcoming environment and increase accessibility led us to upgrade our assisted listening devices throughout our venues and introduce a new affinity group for members of the LGBTQ+ community. We also piloted programming for individuals with Parkinson's disease and their care partners, officially launching the initiative over the summer.

With much gratitude from all of us for their exemplary service, veteran Playhouse Square executives Senior Advisor Art Falco, Chief Operating Officer Emeritus Patty Gaul, and Vice President of Facilities and Capital Tom Einhouse retired from the organization. And with much

excitement, we welcomed new Chief Operating Officer Laura Smith and new President of Real Estate Services Nate Kelly.

Many thanks to all who make our work possible: our steadfast Board of Trustees, talented and skillful staff, enthusiastic volunteers, generous donors who support our not-for-profit mission, and passionate audiences.

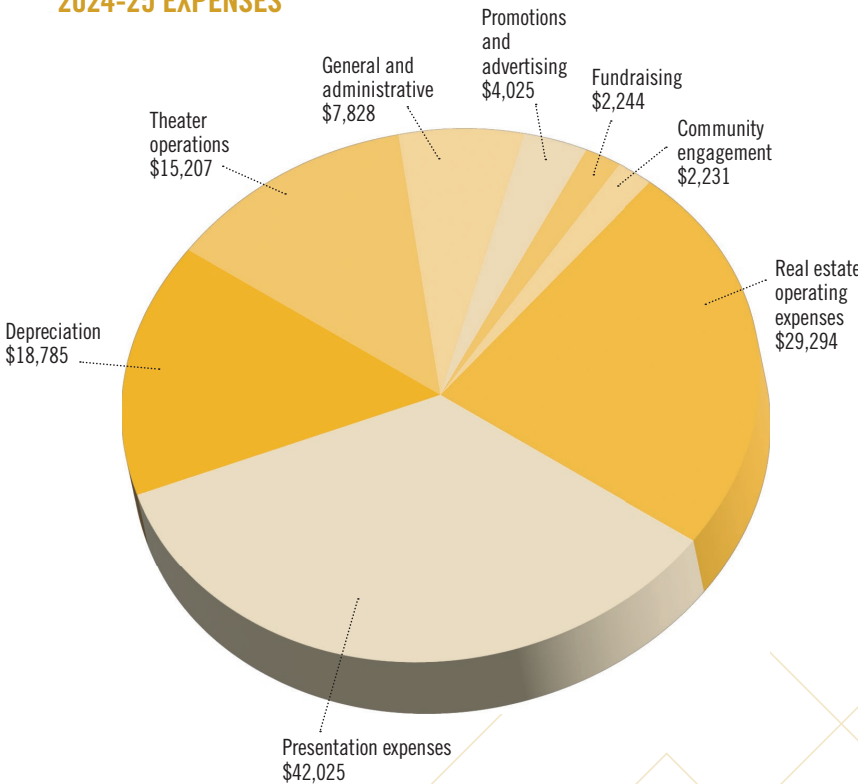
