

**PLAYHOUSE SQUARE CONTEST
GIRL SCOUTS OF NORTHEAST OHIO
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

CONTEST PERIOD: The Playhouse Square Contest for the Girl Scouts of Northeast Ohio (the “**Contest**”) shall take place from 8:00 AM Eastern Time on Friday, September 15, 2023 through 11:59 PM Eastern Time on Sunday, October 15, 2023 (the “**Contest Period**”).

ELIGIBILITY: The Contest is open to girl scouts registered with the Girl Scouts of Northeast Ohio (“**GSNEO**”) who are active at the time of entry. Employees, officers, and directors of GSNEO, Playhouse Square Foundation (“**Administrator**”) and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, members of their immediate family (spouses, parents, children, and siblings and their respective spouses, regardless of where they reside), and persons living in the same household of such employees, officers, and directors (whether or not related), are not eligible to participate in the Contest.

HOW TO ENTER: Parents of eligible persons may enter the Contest by following the instructions provided on playhousesquare.org/girlscouts during the Contest Period. Entrants may be required to provide their full names, mailing addresses, phone numbers, dates of birth, and email addresses. Limit one (1) entry per girl scout during the Contest Period. Additional entries beyond this limit will be void.

CAUTION: ANY ATTEMPT TO UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, ADMINISTRATOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS’ FEES) FROM ANY INDIVIDUAL ATTEMPTING SUCH ACTIONS TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION.

Entries generated by a script, macro, or other mechanical or automated means will be disqualified. Normal internet and phone access and data and usage charges may apply.

WINNER SELECTION: One (1) winner of the Contest will be selected by random drawing of all valid submissions on or about Monday, October 16, 2023. The winner will be contacted by Administrator via email or phone on or about Wednesday, October 18, 2023. The winner is required to respond within twenty-four (24) hours of initial contact. In the event the winner does not respond within twenty-four (24) hours of the initial contact or if the winner declines the prize or is deemed to be ineligible, another winner may be randomly selected from the remaining eligible entries received. Administrator reserves the right, in their sole discretion and without notice, to award the unclaimed prize to an alternate entrant or not to award the unclaimed prize.

Administrator, nor any of their respective parents, subsidiaries, affiliates, directors, officers, owners, shareholders, members, employees, sponsors, licensees, successors, assigns, nor agents are responsible for lost, interrupted, or unavailable network, server, or other connections, miscommunications, failed phone or computer hardware or software or telephone transmissions or technical failures, garbled or jumbled transmissions or other errors of any kind, whether human, mechanical, or electronic, including without limitation the incorrect or inaccurate capture of entry information online, or for lost, late, incomplete, damaged, destroyed, delayed, stolen, misdirected, or illegible entries. Entry materials and data that have been tampered with or altered are void.

The potential winner will be required to submit his or her valid identification information to Administrator, and may be required to execute, have notarized, and return an Affidavit of Eligibility and Release of Liability attesting to the fact that he or she is eighteen (18) years of age or older and that he or she meets all required eligibility requirements. Winner's guest (or parent or legal guardian on behalf of minor guests) may need to execute a Release of Liability prior to the trip. Failure to submit any required materials in a timely manner or noncompliance with these Official Rules may result in disqualification and forfeiture of prizes and, in the sole discretion of Administrator, may cause an alternate potential winner to be randomly selected from among all remaining eligible entries received.

PRIZE DESCRIPTION: One (1) winner will win: (i) four (4) tickets to see the production "Annie" on or about Saturday, March 23, 2024 at 7:30 pm at the Connor Palace with loge seating. The prize will include one (1) night of standard hotel accommodations (two rooms, consisting of 1 suite and 1 double bed room that is adjacent, and all room taxes) at the Crowne Plaza Cleveland at Playhouse Square ("**Crowne Plaza**") in Cleveland, Ohio (the "**Hotel Reservation**"); breakfast for four (4) at Crowne Plaza; and overnight valet parking at Crowne Plaza. The Hotel Reservation will be good through July of 2024 and must be reserved through Crowne Plaza.

PRIZE CONDITIONS: All prize details shall be determined in the sole and absolute discretion of Administrator. Administrator reserves the right to change or alter the prize at any time without notice. The prize winner is solely responsible for all applicable federal, state, and local taxes and any expenses associated with the Contest. No substitution, cash equivalent, or transfer of prize is permitted except at the sole option of Administrator for a prize of comparable or greater value.

ODDS OF WINNING: The odds of winning will depend on the number of eligible entries received.

RELEASE OF LIABILITY AND INDEMNIFICATION: By submitting an entry, each entrant agrees to be bound by these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind whatsoever whether caused by negligence, any intentional act or otherwise, that entrant may have or that may arise against Playhouse Square, and each of their respective parents, subsidiaries, affiliates and related entities, as well as each of the aforementioned parties' respective directors, officers, owners, shareholders, members, partners, employees, representatives, successors, assigns and agents (collectively, the "**Released Parties**"), with respect to or arising out of either (i) entrant's participation; or (ii) the receipt or use of the prizes (including, but not limited to, the substitution or changing of any prizing) awarded in the Contest. By submitting an entry, each entrant further agrees to defend, indemnify, and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, and/or expenses (including, but not limited to, attorneys' fees and other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation; or (ii) the receipt or use of the prizes (including, but not limited to, the substitution or changing of any prizing) awarded in the Contest.

As a condition of entering the Contest, each entrant agrees that (i) any and all disputes, claims, controversies or causes of action arising out of or relating to the Contest, or any prizes awarded (each, a "**Claim**"), shall be (a) arbitrated on an individual basis only, and shall not be consolidated or joined with or in any arbitration or other proceeding involving a Claim of any other party, and (b) settled by binding arbitration in Cuyahoga County, Ohio before a single arbitrator appointed by the American Arbitration Association in accordance with its then governing rules and procedures, and judgment on the award rendered by the arbitrator may be entered by any court having jurisdiction thereof; and (ii) under no circumstance will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses. These Official Rules shall be governed by and construed and interpreted in accordance with the laws of the State of Ohio.

PUBLICITY RELEASE: Except where prohibited by law, in consideration for being permitted to participate in the Contest and the opportunity to win the prize offered in the Contest, each entrant hereby agrees and consents, without further authorization, compensation, or remuneration of any kind, to the use of the entrant's name, likeness, voice, photograph, and/or biographical information in any and all advertising, promotions, and other publicity conducted by GSNEO and/or Administrator and each of their respective parents, subsidiaries, affiliates, agents, licensees, successors and assigns in any media or format now known or hereafter devised, throughout the world, in perpetuity, without limitation unless prohibited by law. Nothing herein will obligate GSNEO or Administrator to make any use of any of the rights set forth herein.

ADVERTISING: GSNEO will advertise the Contest through social media, its website, and girl scout newsletters.

CANCELLATION, SUSPENSION, OR MODIFICATION OF THE CONTEST: Administrator reserves the right to cancel, modify, or suspend the Contest and/or change dates or prizes (to a prize of equal or greater value) of the Contest in case of schedule changes, acts of God, force majeure events, computer viruses or bugs, or corruption of the security or administration of the Contest, or for any other reason at their sole discretion and without notice.

VOID WHERE PROHIBITED: Participation in the Contest is void outside of Ohio and where prohibited or restricted by law, rule, or regulation.
