REPORT TO THE COMMUNITY



DEAR FRIENDS

IF THERE IS ONE WORD TO DESCRIBE OUR 2021-2022 FISCAL YEAR IT IS THIS ONE: COMEBACK. Playhouse Square came roaring back from its prolonged closure due to the COVID-19 pandemic to great enthusiasm from the community.

Following a successful summertime run of *The Choir of Man*, which was extended three times and concluded with a limited run of *The Afterparty* (a show created by the cast just for Cleveland audiences), touring Broadway returned to Playhouse Square with the most famous roar of all: Disney's *The Lion King*.

With precautions such as improved air circulation, reduced touch points, masking and proof of vaccination in place, 43,000 guests came to join the "Circle of Life" as Rafiki called us back to The Pridelands.

40,000 season ticket holders joined us for the KeyBank Broadway Series featuring *The Prom*, *Pretty Woman: The Musical*, *To Kill a Mockingbird* starring Richard Thomas, *Ain't Too Proud – The Life and Times of the Temptations* and Disney's *Frozen*. *My Fair Lady* and *Jesus Christ Superstar*, both rescheduled from 2020, took to our stages as well, with a special only-in-Cleveland enhanced surround-sound experience for *Jesus Christ Superstar* featuring 22 local string musicians accompanying the 11-piece touring band.

Lyricist Sir Tim Rice (*Jesus Christ Superstar*, *The Lion King*, *Evita*, *Aladdin* and more) visited Playhouse Square in May to meet with students from Baldwin Wallace and Cleveland State Universities and receive Playhouse Square's Star Award for Achievement in the Performing Arts.

Musicians and comedians, eager to perform for their fans live and in person once again, began to fill our calendar. Our illustrious resident companies returned to the spotlight once more. And after a two-year delay, we welcomed the Cleveland International Film Festival to its new home at Playhouse Square, which opened with the premiere of our Emmy-Award winning documentary "The Big Comeback," the story of how we reopened to the public in June 2021.

As our stages came back to life, so did the Playhouse Square District: restaurants reopened, The Lumen apartment tower became 90% leased, our hotel – the Crowne Plaza Cleveland – booked a record number of weddings, and workers began to return to their offices.

Our Education Department continued its successful streaming initiative first launched in response to the pandemic. The response from schools was overwhelmingly positive, especially from those who would be unable to travel to Playhouse Square at any

time. The Department is now offering both streaming and live performances for students.

The comeback continued as the yellow school buses lined Euclid Avenue under our marquees as Student Matinee Performances presented by University Hospitals Rainbow Babies & Children's Hospital resumed. And the Dazzle Awards presented by Pat and John Chapman made a triumphant return to the Connor Palace stage in May. High school students representing 29 schools came together to showcase their talents and celebrate the joy of musical theater. The directors representing each school received a special Dazzle Award to recognize their perseverance and dedication in continuing their programs to the best of their abilities through the pandemic, and the students debuted the original song "A Chance to Shine" written for the program.

More than 118,000 students from 26 counties across the region participated in our education programming during the 2021-2022 fiscal year.

In the spring, we released the results of a combined economic impact study with the Cleveland Museum of Art, the Cleveland Orchestra and the Rock and Roll Hall of Fame. The conclusion of the study is undeniable: the arts industry serves as a significant

revenue generator and source of employment in the State of Ohio. Combined, our four organizations generate an economic impact of \$822 million on Greater Cleveland and support 6,818 jobs. Playhouse Square's annual economic impact is \$359.1 million and we are proud to play such an important part in the strength of our region.

Everything we accomplished was due to one of the most gratifying comebacks of all: our ability to bring our staff back from the furlough necessitated by the pandemic. Rejoining the small team who kept the organization going during our closure, the returning staff immediately resumed their roles to welcome artists and audiences back to our theaters.




